Guide to EU Window Chinese Government Scholarship

(2024-2025 academic year)

EU Window Chinese Government Scholarship is a full scholarship established by the Ministry of Education, PR China, for candidates from EU member countries, under the framework of China-EU High Level People-to-People Dialogue (HPPD).

The purpose of this program is to expand student exchanges between China and the European Union.

I Supporting Categories, Duration and Instruction Language

1. Supporting Category

This program supports undergraduate students, graduate students, general scholars and senior scholars.

2. Duration

The scholarship covers both major study and Chinese language (preparatory study), as specified in the Admission Letter.

3. Language Instruction

Undergraduate scholarship recipients must register for Chinese-taught credit courses. Graduate and non-degree scholarship students can register for either the Chinese-taught program or the English-taught program if applicable. II Scholarship Coverage

The EU Program provides a full scholarship of tuition waiver, accommodation, stipend, and comprehensive medical insurance (Without travel expense). Please refer to "Chinese Government Scholarship Coverage and Standard" for details.

III Eligibility

To be eligible, applicants must

- be a citizen of an EU country and be in good health both mentally and physically.
- be a high school graduate under the age of 25 when applying for undergraduate programs;
- be a bachelor's degree holder under the age of 35 when applying for master's programs;
- be a master's degree holder under the age of 40 when applying for doctoral programs;
- be a high school graduate (at least) under the age of 45 when applying for general scholar programs;
- be a master's degree holder or an associate professor (or above) under the age of 50 when applying for senior scholar programs;
- have acquired the Chinese proficiency of HSK Level 3 when applying for Chinesetaught undergraduate or general scholar programs (studying Chinese language are exempted);
- have acquired the Chinese proficiency of HSK Level 3 when applying for Chinesetaught senior scholar programs;
- have acquired the Chinese proficiency of HSK Level 4 when applying for Chinesetaught master's or doctoral programs;
- meet the admission requirements of the applied universities in terms of academic ability, language proficiency and other relevant criterial.

IV Where to Apply and When to Apply

After online application, you need to send an email for submission confirmation information to Chinamissiontoeu@gmail.com. The email should be entitled as "CGS 2024 Application + Serial Number+ Name"

Online application should be submitted no later than Feb 15, 2024.

V Application Documents

- a) Application Form for Chinese Government Scholarship (in Chinese or English).
- b) Copy of Passport Home Page: Applicant shall submit a clear scanned copy of his/her ordinary passport with validity later than March 1, 2025. If the validity of the current passport does not meet the requirement, please apply for a new passport before submitting the application. For applicants who cannot apply for passports before submitting their applications due to objective reasons, with the permission of dispatching authorities, they may submit scanned copy of identity certificates or official documents containing the applicants' "English name, Gender, Nationality, Date of Birth" and other information.
- c) Notarized highest diploma: Prospective diploma winners must submit official proof of student status by their current school. Documents in languages other than Chinese or English must be attached with notarized Chinese or English translations.
- d) Academic transcripts: Transcripts in languages other than Chinese or English must be attached with notarized Chinese or English translations.
- e) Language qualification certificates. Applicants for Chinese-taught programs must submit valid HSK reports in accordance with the corresponding Chinese proficiency requirements. Applicants for other language-taught programs shall provide relevant language proficiency certificates according to the universities' requirements, like IELTS or TOFEL report.
- f) Admission documents. To apply for master's and doctoral degree or as general and senior scholars, applicants shall provide admission documents issued by the applied universities. Admission documents include admission notice, pre-admission letter, invitation from professors and etc.
- g) A Study Plan or Research Proposal in Chinese or English. (A minimum of 200 words for undergraduates, 500 words for non-degree students, and 800 words for postgraduates.)
- h) Recommendation letters: Applicants for graduate programs or senior scholar programs must submit two letters of recommendation in Chinese or English from professors or associate professors.
- i) Example of Art. To apply for art or design related majors, applicants could submit their own works through "Example of Art/Other Supporting Documents" in the system. Applicants could also provide such materials to the applied universities directly in other ways.
- j) Applicants under the age of 18 should submit the valid documents of their legal guardians in China.
- k) Applicants planning to stay in China must submit a photocopy of the Foreigner Physical Examination Form completed in English (the original copy should be kept by the applicant. The physical examinations must cover all the items listed in the Foreigner Physical Examination Form. Incomplete records or those without the **signature** of the attending physician, the **official stamp** of the hospital or a **sealed photograph** of the applicants are invalid.
 - Please select the appropriate time to take physical examination as the result is valid for only 6 months).
- 1) Non-criminal record report. The applicant shall submit a valid certificate of Non-

- Criminal Record issued by the local public security authority, usually issued within 6 months prior to the submission date of the application.
- m) In the application confirmation email, you are required to offer the exact address to receive the registered mail from the local postal service in Brussels between July and August, 2024. (IMPORTANT)

Reminder: All uploaded supporting documents must be clear, authentic and valid. Applicants are recommended to use professional device to scan the relevant documents. Applicants shall bear the consequences caused by unclear or unidentifiable uploaded materials.

VI Placement & Scholarship Confirmation

- 1. Application documents of recommended candidates from Mission of P. R China to the European Union will be considered by CSC for eligibility and qualification. Ineligible or incomplete applications will not be considered;
- 2. If applicants are rejected by their applying (first choice) university, CSC won't replace them to another host university; (IMPORTANT)
- 3. After placement confirmation by Chinese universities, scholarship recipients will get Chinese government scholarships to study in China with approval by CSC. Each scholarship recipient will be granted with no more than one scholarship.
- 4. CSC reviews the placement results, approves the List of Scholarship Recipients and sends the admission documents to the Office for Education and Culture, Mission of P.R.China to the European Union around July. The Office for Education and Culture, Mission of P.R.China to the European Union will send the admission documents, i.e., Admission Letter and Visa Application Form for Study in China (JW201), to the scholarship recipients.
- 5. Scholarship recipients shall not change their host university, field of study, or duration of study unless they give up the grant.
- 6. Scholarship will not be reserved if scholarship recipient cannot register before the registration deadline.
